ACCEPTABLE DOCUMENTS LIST
COMPLIANT DL-ID CARD

To prove identity, you must show proof of the following five elements:

1 - Full Legal Name; 2 - Date of Birth; 3 - Legal Presence in US; 4 - Social Security Number; and 5 - Ohio Street Address

To prove an element, the element must be contained on the document.

TWO documents, from different sources, proving Ohio Street Address that are listed on the Acceptable Document List are required for proof of Ohio residency.

Additional Proof of Full Legal Name Documents

Full legal name consists of first name, middle name, and last name without the use of initials or nicknames. If the documents presented do not prove full legal name or are inconsistent, additional documents must be presented.

The following documents are acceptable for this purpose:

- **Marriage Certificate or Marriage License**
- **Certified copy of a decree of divorce, dissolution, or annulment of marriage**
- **Certified copy of a court ordered name change**

BMV 2336 “PROOF OF OHIO RESIDENCY – CERTIFIED STATEMENT” in any of the following situations: <ol style="list-style-type: none"> 1) In the case of a dependent child, from the CHILD'S PARENT OR GUARDIAN who has proof for the same address, signed in the presence of a BMV official. The parent or legal guardian must provide proof of identity, two forms of Ohio Street Address, and relationship to the dependent child. 2) In the case of married person, from the applicant's spouse who has proof for the same address, signed in the presence of a BMV official. The spouse must provide proof of identity, two forms of Ohio Street Address, and proof of marital relationship. 3) In the case of a nursing home patient, a formal statement of residency issued by a nursing home official. Note: One additional document, from a different source, is also required to prove Ohio Street Address. 					X
