IMPORTANT INFORMATION

A "Classic Motor Vehicle" means a motor vehicle that is over twenty-six years old.

A classic motor vehicle auction must take place on a different date and time than a regular motor vehicle auction.

The licensed auctioneer must be a resident of Ohio.

RECORDS REQUIRED

Records must be kept for three years, be reasonably available for inspection and shall include the following:

1. Certificate of title number, county and state of registration;
2. The year, make, model and vehicle identification number;
3. The name and address of the person offering the vehicle for sale;
4. The date the vehicle is offered for sale;
5. The name and address of the person buying the vehicle;
6. The purchase price;
7. Odometer reading at the time of the auction;
8. Odometer statement from the person offering the vehicle for sales.

DEFINITIONS

"Person" means an individual, sole proprietor, corporation, limited liability company, association, partnership, and any combinations of individuals.

"Auction firm" means a person who provides auction services and is licensed by the Department of Agriculture.

"Auction services" means arranging, managing, and sponsoring a personal property auction. "Auction services" includes the taking and advertising of personal property on consignment to be sold at auction by a licensed auctioneer.
