PROOF OF FINANCIAL RESPONSIBILITY

YOU WILL LOSE YOUR DRIVER LICENSE FOR AT LEAST 90 DAYS IF YOU DRIVE WITHOUT INSURANCE OR OTHER FR PROOF

- In Ohio, it is illegal to drive any motor vehicle without insurance or other financial responsibility proof (FR Proof). It is also illegal for any motor vehicle owner to allow anyone else to drive the owner's vehicle without FR Proof.
 - FR PROOF IS REQUIRED • Whenever a police officer issues a traffic ticket • At all vehicle inspection stops
 - Upon every traffic court appearance • After every motor vehicle accident • Upon random checks by the Registrar of Motor Vehicles.
- ANY DRIVER OR OWNER WHO FAILS TO SHOW PROOF OF INSURANCE OR OTHER COVERAGE WILL: Lose his or her driver license for 90 DAYS on first offense, ONE YEAR on second offence and TWO YEARS on additional offenses • Lose his or her license plates and vehicle registration • Pay reinstatement fees of \$75.00 first offense, \$250.00 for second offense, and \$500.00 any additional offense • Pay a \$50.00 penalty for any failure to surrender his or her driver license, license plates, or registration AND • Be required to maintain special FR coverage ("High-risk" insurance or equivalent) on file with the Bureau of Motor Vehicles (BMV) for THREE or FIVE YEARS.
- ONCE THIS SUSPENSION IS IN EFFECT: Any driver or owner who violates the suspension will have his or her vehicle immobilized and his or her license plates confiscated for at least 30 DAYS first offense and 60 DAYS second offense. For third or subsequent offenses, the vehicle will be forfeited and sold and the person will not be permitted to register any motor vehicle in Ohio for FIVE YEARS.
 - IF YOU ARE INVOLVED IN AN ACCIDENT IN WHICH ANYONE IS INJURED OR DAMAGES EXCEED \$400.00, YOU MUST FILE A BMV CRASH (ACCIDENT) REPORT. This is in ADDITION to any police accident report. Failure to file this BMV Crash report will result in a suspension until the report is filed.
 - IF YOU ARE INVOLVED IN AN ACCIDENT WITHOUT INSURANCE OR OTHER FR COVERAGE: In addition to all the penalties listed above, you may have • A SECURITY SUSPENSION for TWO YEARS or more and • A JUDGMENT SUSPENSION INDEFINITELY (until all damages have been satisfied).
 - THESE PENALTIES ARE IN ADDITION TO ANY FINES OR PENALTIES IMPOSED BY A COURT OF LAW.
 - WARNING: THESE LAWS DO NOT PREVENT THE POSSIBILITY THAT YOU MAY BE INVOLVED IN AN ACCIDENT WITH A PERSON WHO HAS NO INSURANCE OR OTHER FR PROOF.
 - I HAVE RECEIVED THE CUSTOMER COPY OF FINANCIAL RESPONSIBILITY NOTICE.

NOTE: YOU MUST HAVE YOUR VEHICLE INSPECTED ANNUALLY BY THE HIGHWAY PATROL IF YOUR VEHICLE IS MANUFACTURED TO TRANSPORT MORE THAN FIFTEEN (15) PASSENGERS, INCLUDING THE DRIVER, OR HAS A GROSS VEHICLE WEIGHT THAT EXCEEDS TEN THOUSAND POUNDS.

INSTRUCTIONS

SENIOR BUS (R.C. 4503.04) Below affidavit must be completed.

The owner of a bus used principally for the transportation of persons sixty-five years of age or older may obtain Seniors license plates. To qualify for Seniors bus license plates, the bus must seat 10 or more.

TEMPORARY FARM BUS (R.C. 4503.04) Below affidavit must be completed.

Temporary farm bus vehicle license plates can be issued for a period of ninety days. An additional set of plates can be purchased, if necessary, for another ninety day period. Such plates may not be issued for more than two (2) ninety-day periods in any licensing year. The bus will be used solely for the transportation of agricultural employees, and used only in transportation of such employees as are needed in the operation of the farm. Statement must be completed and signed by the owner(s) or lessee(s).

CAMP BUS (R.C. 4503.17) Below statement and affidavit must be completed.

The owner of a school bus under contract with a board of education may use such bus during summer vacation periods to transport children and their authorized supervisors to and from any camping function sponsored by a nonprofit, tax-exempt, charitable, or philanthropic organization. Certificate for school bus from State Highway Patrol required.

THE FOLLOWING ITEMS MUST BE RETURNED TO THE OHIO BMV TO REGISTER BY MAIL:

1. Total amount due. Make check or money order payable to: Ohio Treasurer Kevin L. Boyce, BMV, Add permissive tax to total due if applicable.
2. The R.C. 4503.19 requires that you ADD \$2.00 to the above fees for replacement plates if your vehicle is currently registered or has been registered within the last 12 months.
3. Current OHIO vehicle registration card for above vehicle. Temporary tag registration or registration card which expired more than 11 months ago is unacceptable. If registration card is unavailable, send Certificate of Title or Memorandum Title (original document only). You may take these documents to any deputy registrar agency. The deputy will verify the vehicle information for a service fee.
4. Required documents as stated ABOVE (see instructions) for the type of registration being requested.
5. Affidavit and/or statement must be completed.
6. Completed and signed application. Mailing address on front.
