## AFFIDAVIT FOR A NEW MOTOR VEHICLE DEALER SHOW

Section 4517.22 of the Ohio Revised Code (R.C.)

Upon approval of the registrar, any group of new motor vehicle dealers licensed under Chapter 4517 of the R.C. may display motor vehicles at a new motor vehicle dealer show (show) within the general market area that has been designated by the show sponsor.

**NOTE:** Only a manufacturer or distributor is permitted to display a single unit new motor vehicle. (An affidavit for a manufacturer display (BMV 4364) or distributor display (BMV 4365) must be submitted.)

All affidavits must be accompanied with the List of Dealer Participants form (BMV 4446) and a copy of the invitation.

### AS A SHOW REPRESENTATIVE THAT WILL BE HOLDING A SHOW, I AFFIRM THE FOLLOWING:

INITIAL	An invitation was sent to <u>all</u> new motor vehicle dealers licensed under Chapter 4517 of the R.C. dealing in competitive types of motor vehicles in the designated general market area.
INITIAL	The terms of the invitation were reasonable and nondiscriminatory.
INITIAL	The show will not last more than ten (10) days, notwithstanding the requirements of R.C. 4517.22 (J).
INITIAL	No contracts will be signed, deposits taken, or sales consummated at the show.
INITIAL	A copy of each invitation will be retained for one year after the show, and available upon request of the registrar.
INITIAL	There will be two (2) or more competitive type new motor vehicle dealers present at all times during the duration of the show. (If you cannot affirm, please answer the question below)

INITIAL	An invitation was sent to <u>all</u> new motor vehicle dealers licensed under Chapter 4517 of the R.C. dealing in competitive types of motor vehicles in the county where the fair is being held.
INITIAL	All other requirements as set forth in R.C. 4517.22 have been met, as affirmed above.
INITIAL	Only one new motor vehicle dealer licensed under Chapter 4517 of the R.C. has accepted the invitation.

**GENERAL MARKET AREA**

Provide the contiguous geographical market area that was designated to invite all new motor vehicle dealers dealing in competitive types of motor vehicles. The general market area shall not unreasonably exclude any licensed new motor vehicle dealer. (Attach a clearly marked map showing radius or encircled general market area)

**NOTE:** The general market area designated by the show sponsor does not preclude any participating new motor vehicle dealer from first complying with the designated market area stipulated contractually in their agreement with the manufacturer. Furthermore, any disputes arising due to the dealer’s assigned area of responsibility in their contract with the manufacturer will be between them, and the Bureau of Motor Vehicles shall not intervene.

I understand that any provisions as set forth in 4517.22 of the R.C. that have been violated, the motor vehicle dealer board may order an administrative penalty for each violation, including but not limited to each sale that occurs, and each day a violation occurs or continues to occur.

I affirm and understand that all statements in the foregoing affidavit and in any attachments submitted are true and correct and that I have the authority to sign this affidavit and to make the statements contained herein and have initialed as required.
