The weight of all farm trucks and noncommercial trailers shall be the weight of the vehicle fully equipped as determined on a standard scale.

1. A farm truck is defined as one used in the transportation from the farm of products of the farm, including livestock and its products, poultry and its products, floricultural and horticultural products, and in the transportation to the farm of supplies for the farm including tile, fence and every other thing or commodity used in agricultural, horticultural, livestock and poultry production, and livestock, poultry and other animals and things used for breeding, feeding or other purposes connected with the operation of the farm or farms, but such use shall not include the operation of trucks by commercial processors of agricultural products.

The term farm supplies shall include fuel used exclusively in the operation of a farm, including one or more homes located on and used in the operation of one or more farms and furniture and other things used in and around such homes.

**NOTE: A farm truck must be rated one ton or more by the manufacturer.**

2. Noncommercial trailer is defined as any trailer, except a travel trailer, having a gross weight of no more than ten thousand pounds (10,000) and used exclusively for purposes other than engaging in business for a profit.
